

**U.S. SKI & SNOWBOARD  
ATHLETE SELECTION PROCEDURES  
GANGWON 2024 YOUTH OLYMPIC GAMES  
ALPINE SKIING  
April 4, 2023**

**1. SELECTION SYSTEM**

1.1. Provide the minimum eligibility requirements for an athlete to be considered for selection to the Team:

1.1.1. Nationality/Passport requirements:

- Athlete must be a national of the United States at the time of nomination.
- Athlete must hold a valid U.S. passport that will not expire for six months after the conclusion of the Games.

1.1.2. Minimum International Olympic Committee (IOC), standards for participation:

- Any competitor in the Gangwon 2024 Youth Olympic Games must be a national of the country of the National Olympic Committee (NOC) which is entering such competitor. For additional information regarding an athlete who is a national of two or more countries, has changed his/her/their nationality or acquired a new nationality, refer to the Olympic Charter (Rule 41).

1.1.3. Minimum International Federation (IF) standards for participation (if any):

- Athletes must be registered with the International Ski and Snowboard Federation (FIS).
- Athletes must be born between January 1, 2006 and December 31, 2007.
- Athletes must comply with the Olympic Charter.

1.1.4. Other requirements (if any):

- Athlete must be a member in good standing of U.S. Ski & Snowboard. Any athlete age 18 or older will be required to undergo a background screen in accordance with the current USOPC Background Check Policy.

- Any athlete age 18 or older as of the Closing Ceremony will be required to remain current with the U.S. Center for SafeSport’s education and training requirements in accordance with the USOPC Athlete Safety Policy.
- Athletes must attend for the entire duration of the Gangwon 2024 Youth Olympic Games.
- Athletes must participate in the cultural and education program, and Mixed Team events, as requested.
- Athletes must have successfully completed all Gangwon 2024 Youth Olympic Games Registration requirements by stated deadline.

1.2. Selection Events:

1.2.1. Athletes must have obtained YOG FIS points subject to the following performance criteria:

- Slalom and Giant Slalom: YOG FIS points in at least one (1) FIS alpine event
- Super-G: YOG FIS points in Downhill, Super-G, or Giant Slalom
- Alpine Combined: YOG FIS points in Downhill, Super-G, Giant Slalom, or Alpine Combined

YOG FIS points are earned in accordance with the FIS Rules for FIS Points during the YOG qualification period from July 1, 2022 to December 17, 2023.

1.2.2. Provide the event names, dates and locations of all trials, events and camps to be used as part of the selection process.

Qualification races:

- All FIS races included in the calculation of the YOG FIS points list published at the time of nomination date of December 18, 2023. Athletes must participate in the FIS sanctioned events during the selection period
- 2023 U16 U.S. National Championships, Mission Ridge, WA – April 3-7, 2023

- 1.2.3. Provide event names, dates, locations, and description of how athletes qualify for the trials, events, and camps listed above in 1.2.1. (if any).

Qualifiers for 2023 U16 U.S. National Championships:

- Eastern Region U16 Championships, Sugarloaf, ME – March 13-17, 2023
- Rocky/Central U16 Junior Championships, Winter Park, CO – March 6-10, 2023
- Western Region U16 Championships, Sun Valley, ID – March 21-24, 2023

- 1.3. Provide a comprehensive, step-by-step description of the method that explains how athletes will go through the selection process (include maximum Team size).

Up to three (3) women and three (3) men will be named based on quotas established by the FIS.

- 1.3.1. If quota is three (3), the selection criteria will be applied in the following order:

- a) One (1) athlete will be selected ranked by the sum of world ranks in Slalom (SL) and Giant Slalom (GS) on the YOG FIS points list at the end of the qualification period. Ties will be broken by the single best world rank on the YOG FIS points list in SL or GS. Additional ties will be broken by the single best FIS point result in SL or GS during the YOG qualification period.
- b) Considering all remaining eligible athletes, one (1) athlete will be selected who achieves two 1<sup>st</sup> place results in SL, GS, or SG at the 2023 U16 U.S. National Championships, evaluating only U.S. athletes. Ties will be broken by the single best National point result achieved at the 2023 U16 U.S. National Championships.
- c) Considering all remaining eligible athletes, up to two (2) athletes will be selected ranked by the lowest sum of the best two world ranks on the YOG FIS points list in Slalom (SL), Giant Slalom (GS), and Super-G (SG) at the end of the qualification period. Ties will be broken by the single best world rank on the YOG FIS points list in SL or GS, or SG. Additional ties

will be broken by the single best FIS point result in SL or GS, or SG during the YOG qualification period.

1.3.2. If quota is two (2), the selection criteria will be applied in the following order:

- a) One (1) athlete will be selected ranked by the sum of world ranks in Slalom (SL) and Giant Slalom (GS) on the YOG FIS points list at the end of the qualification period. Ties will be broken by the single best world rank on the YOG FIS points list in SL or GS. Additional ties will be broken by the single best FIS point result in SL or GS during the YOG qualification period.
- b) Considering all remaining eligible athletes, one (1) athlete will be selected who achieves two 1<sup>st</sup> place results in SL, GS or SG at the 2023 U16 U.S. National Championships, evaluating only U.S. athletes. Ties will be broken by the single best National point result achieved at the 2023 U16 U.S. National Championships.
- c) Considering all remaining eligible athletes, up to one (1) athlete will be selected ranked by the lowest sum of the best two world ranks on the YOG FIS points list in Slalom (SL), Giant Slalom (GS) and Super-G (SG) at the end of the qualification period. Ties will be broken by the single best world rank on the YOG FIS points list in SL or GS, or SG. Additional ties will be broken by the single best FIS point result in SL or GS, or SG during the YOG qualification period.

1.3.3. If quota is one (1), the selection criteria will be applied in the following order:

- a) One (1) athlete will be selected ranked by the sum of world ranks in Slalom (SL) and Giant Slalom (GS) on the YOG FIS points list at the end of the qualification period. Ties will be broken by the single best world rank on the YOG FIS points list in SL or GS. Additional ties will be broken by the single best FIS point result in SL or GS during the YOG qualification period.

## **2. DISCRETIONARY SELECTION (if applicable)**

2.1. Provide rationale for utilizing discretionary selection (if any):

Discretion will be used if a selected athlete is injured or sick, or for some other reason cannot attend the 2024 Youth Olympic Games.

2.2. List the discretionary criteria and explain how they will be used (if any):

- Sum of world ranks in Slalom (SL) and Giant Slalom (GS) on the YOG FIS points list at the end of the qualification period
  - Athletes who have a sum less than 800 for women and 1000 for men
- Exceptional performances at the 2023 U16 National Championships
  - Evaluating only U.S. athletes, an athlete who won SL or GS by a substantial time differential, generating more than 10 race points for the 2<sup>nd</sup>-place finisher
- Single best world rank in Slalom (SL) or Giant Slalom (GS) on the YOG FIS points list at the end of the qualification period

2.3. Provide the name of the committee that will be responsible for making discretionary selections, along with a complete list of the members' titles currently serving on the committee:

- Anouk Patty – Chief of Sport, U.S. Ski & Snowboard
- Chip Knight – Alpine Development Director, U.S. Ski & Snowboard
- Karen Ghent – Alpine Sport Committee Chair, U.S. Ski & Snowboard
- Warner Nickerson – AAC Alpine Athlete Representative
- Andrew Weibrecht – USOPC AAC Athlete Representative

2.3.1. Specify the process that will be used to identify and handle any potential conflicts of interest involving a member of the committee.

If there is a conflict of interest, the committee member will be recused and another person within the organization as follows:

- Anouk Patty would be replaced by Sophie Goldschmidt, President and Chief Executive Officer
- Chip Knight would be replaced by Patrick Riml, Alpine Sport Director
- Karen Ghent, Warner Nickerson, and Andrew Weibrecht would be replaced by an Athlete Representative appointed by the AAC

### **3. REMOVAL OF ATHLETES**

3.1. Prior to entry by name to the Local Organizing Committee by the USOPC, U.S. Ski & Snowboard has jurisdiction over potential nominees. An athlete who is nominated to the Team by U.S. Ski & Snowboard may be removed for any of the following reasons, as determined by U.S. Ski & Snowboard:

3.1.1. Voluntary withdrawal. Athlete must submit a written letter to the U.S. Ski & Snowboard President & CEO and Chief of Sport.

- 3.1.2. Medical disqualification. Injury or illness that limits the athlete from performing at their highest level (as determined by YOG coaching staff) may result in medical disqualification. Injury or illness must be certified by a physician (or medical staff) approved by U.S. Ski & Snowboard. If an athlete refuses verification of his/her/their illness or injury by a physician (or medical staff) approved by U.S. Ski & Snowboard, his/her/their injury will be assumed to be debilitating and he/she/they may be removed.
- 3.1.3. Failure to participate in Mandatory Training and/or Competition as defined in Section 9 of these procedures.
- 3.1.4. Violation of the U.S. Ski & Snowboard's Code of Conduct ([Attachment A](#)).
- 3.1.5. Non-compliance with the eligibility requirements listed in Section 1.1. of these selection procedures.

An athlete who is removed from the Team pursuant to this provision has the right to a hearing per U.S. Ski & Snowboard's [Bylaws](#) and the USOPC's Bylaws, Section 9.

- 3.2. Once athlete entries have been submitted to the Local Organizing Committee by the USOPC, the USOPC has jurisdiction over the Team, at which time, in addition to any applicable NGB Code of Conduct, the USOPC's Code of Conduct and Grievance Procedures apply. - 3.3. An athlete may be removed as a nominee to the Team or from the Team for an adjudicated violation of IOC, PASO, IPC, WADA, IF, USADA and/or USOPC anti-doping protocol, policies and procedures, as applicable.

#### **4. REPLACEMENT OF ATHLETES**

- 4.1. Describe the selection and approval process for determining replacement athlete(s) should a vacancy occur:
  - 4.1.1. Prior to submission of Entries by Name to the Local Organizing Committee, including any applicable group or committee:

The next-best athlete will be selected ranked by the single best world rank in SL or GS at the end of the qualification period. Ties will be broken by the single best FIS point result in SL or GS during the YOG qualification period.

- 4.1.2. After submission of Entries by Name to the Local Organizing Committee, including any applicable group or committee:

The next-best athlete will be selected ranked by the single best world rank in SL or GS at the end of the qualification period. Ties will be broken by the single best FIS point result in SL or GS during the YOG qualification period.

## **5. SUPPORTING DOCUMENTS**

US Ski & Snowboard will retain the approved Selection Procedures and all supporting documents, including scouting or evaluation forms, etc., and data from the selection process for six months past the date of the Closing Ceremony of the Games.

## **6. REQUIRED DOCUMENTS**

In addition to the USOPC Code of Conduct, the following documents are required to be signed by an athlete as a condition of nomination to the Youth Olympic Games and are included as attachments:

## **7. PUBLICITY/DISTRIBUTION OF PROCEDURES**

The USOPC approved Selection Procedures (complete and unaltered) will be posted/published by the NGB in the following locations:

These procedures will be posted as soon as possible, but not more than five business days following notice of approval by the USOPC.

## **8. DATE OF NOMINATION**

The Nomination of Athletes form, including replacements, will be announced to all athletes and submitted to the USOPC on or before December 18, 2023.

## **9. MANDATORY TRAINING AND/OR COMPETITION**

Not applicable.

## **10. ANTI-DOPING REQUIREMENTS**

Athletes must adhere to all IOC, IPC, PASO, WADA, IF, USADA and USOPC anti-doping protocols, policies and procedures, as applicable. This includes participation in Out-of-

Competition Testing as required by the IOC, IPC, PASO, WADA, IF, USADA and USOPC Rules, as applicable.

However, the selections are always subject to unforeseen, intervening circumstances, and realistically may not have accounted for every possible contingency.

If any force of nature, or force majeure, should cause the alteration or cancellation of any of the selection events listed in this document, these selection procedures will be revised, pursuant to their resubmission to the USOPC.


