SECTION 1: OVERVIEW

These procedures outline the pathway for selection to the Milan-Cortina 2026 Winter Olympic Games in Snowboarding.

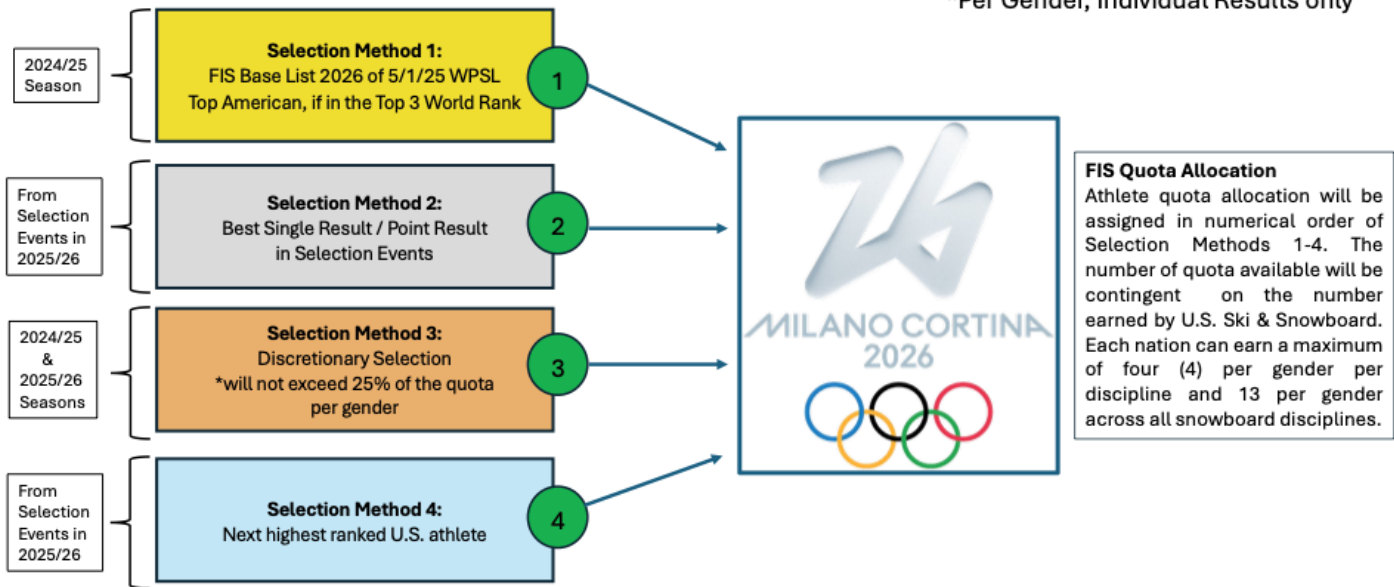
The maximum Team size can be 26 athletes (13 men, 13 women) with a maximum of 4 athletes per discipline, in each gender, permitted to start each competition. However, final Team size will depend on earned International Ski and Snowboard Federation (FIS) quota. FIS quotas are awarded to the National Olympic Committee (NOC).

SECTION 2: SELECTION PROCESS DIAGRAM

The following provides a high-level overview of how athletes will be nominated to the Team:

SECTION 3: ATHLETE REQUIREMENTS

1. Nationality/Passports Requirements:

- Have a valid United States passport at the time of nomination that does not expire for six months after the conclusion of the 2026 Winter Olympic Games (Games).

2. Minimum International Olympic Committee (IOC) Requirements:
 - Abide by the rules in the Olympic Charter, including nationality/citizenship requirements.
 - For additional information regarding an athlete who is a national of two or more countries, has changed his or her nationality or acquired a new nationality, refer to the Olympic Charter (Rule 41).
 - Abide by the IOC Eligibility of Conditions Form/Conditions of Participation Form.
3. Organizing Committee of the Olympic Games (OCOG) Requirements:
 - Comply with all rules and policies implemented by the OCOG or Milano-Cortina 2026.
4. International Federation Requirements:
 - Comply with all FIS eligibility requirements found here (see Qualification): <https://olympics.com/ioc/documents/olympic-games/milano-cortina-2026-olympic-winter-games>.
5. United States Olympic and Paralympic Committee (USOPC) Requirements:
 - Comply with all USOPC rules applicable to the Games (e.g., Demonstrations).
 - Complete all USOPC Games Registration requirements by the stated deadline.
 - Comply with the USOPC Delegation Terms, including the Conduct Requirements, which will be made available here: <https://www.usopc.org/games-and-qualification>
 - Comply with the [USOPC Athlete Safety Policy](#) and the [U.S. Center for SafeSport Code](#) including education and training requirements.
 - Comply with the current [USOPC Background Check Policy](#).
6. NGB Requirements:
 - Athlete must possess a valid USA-coded FIS license for the 2025-2026 season.
 - Comply with the NGB Athlete Agreement.
 - Comply with the [NGB Code of Conduct](#).
 - Comply with the [NGB SafeSport Program](#).
 - Athlete must have an active NGB membership in good standing.
 - Athlete does not have an active suspension from the U.S. Center for SafeSport that would make the Athlete ineligible to participate in the Games.
 - Athlete does not have an active sanction for an anti-doping rule/policy violation that would make the Athlete ineligible to participate in the Games.

SECTION 4: OTHER MINIMUM REQUIREMENTS TO BE ELIGIBLE FOR THE TEAM

- Agree to be bound by and adhere to all IOC, World Anti-Doping Agency (WADA), FIS, United States Anti-Doping Agency (USADA), and USOPC anti-doping protocols, policies and procedures, as applicable. This includes participation in Out-of-Competition Testing and an agreement to be bound to the results management authority of the IOC, WADA, FIS, USADA, or other Anti-Doping Organization as applicable.
- Meet all health and safety protocols, to include vaccine requirements and/or testing requirements set forth by government, local laws, USOPC, FIS, and/or the OCOG.

SECTION 5: EVALUATIVE EVENTS

Event names, dates, and locations of all trials, competitions, and camps to be used as part of the selection process are listed below.

- Only individual event results will be considered as part of the evaluative process.
- Please note all dates are based on long range calendars and are subject to change. It is the responsibility of each athlete to regularly check the calendars to ensure they are aware of all schedule changes.

The following events will be used for evaluation for Selection Method 1:

- All FIS (Snowboard Cross and Parallel Giant Slalom/Parallel Slalom) and WSPL (Halfpipe and Slopestyle/Big Air) events from the 2024/25 season.

The following events will be used for evaluation for Selection Methods 2 & 4:

- Snowboard Halfpipe Evaluative Events:
 - World Cup 1 - Copper, USA – December 19-20, 2025
 - World Cup 2 - Aspen, USA – January 7-10, 2026
 - World Cup 3 - Laax, SUI – January 16-17, 2026
- Snowboard Slopestyle/Big Air Evaluative Events:
 - World Cup 1 - Aspen, USA – January 31 - February 2, 2025
 - World Cup 2 - Steamboat, USA – December 13-14, 2025
 - World Cup 3 - Aspen, USA – January 7-9, 2026
 - World Cup 4 - Laax, USA – January 15-17, 2026
- Snowboard Cross Evaluative Events:
 - All individual SBX World Cups in the 2025/26 season through January 18, 2026
- Snowboard Parallel Giant Slalom Evaluative Events:
 - All individual PGS World Cups in the 2025/26 season through January 18, 2026
- The schedule of competitions will be posted at www.fis-ski.com when approved.

The following events will be used for evaluation for Selection Method 3:

- World Cup events listed above from the 2024-25 season and/or World Cup events listed above in the 2025-26 season prior to January 19, 2026.

SECTION 6: SELECTION PROCESS

Step-by-step description of the selection process including an overview of the FIS Qualification System.

6.1 QUALIFICATION FOR EVALUATIVE EVENTS

6.2 FIS QUOTA ALLOCATION AND TEAM NOMINATION

The International Olympic Committee (IOC) has determined that a maximum of twenty-six (26) athletes representing any one nation may compete in the 2026 Winter Olympic Games across all events in Snowboard with a maximum of up to thirteen (13) male and thirteen (13) female athletes. U.S. Ski & Snowboard may enter up to four (4) athletes per gender per event as determined by FIS. Total USA Team size will be determined by FIS on January 19, 2026 using the Olympic Quota Allocation List. FIS will reallocate all unused quota places on January 21-22, 2026.

Nomination to the Olympic Team does not guarantee the right to start a competition at the Games. Start selections are at the discretion of the U.S. Ski & Snowboard coaching staff, and medical staff where applicable, and will be based on a number of factors including course profiles, technique demands, recent trends in fitness and results, health, tactical skills, and other factors possibly contributing to starting the athletes best prepared for success in a given event.

Athletes will be nominated to the Olympic Team in the order of:

1. Top USA Athlete, if ranked in the top three (3) on the WSPL Ranking List as of 5/1/2025 (SS/BA and HP) or the FIS Base List 2026 (SBX / PGS) (Selection Method 1)
 2. Top 10 World Cup Result (Selection Method 2)
 3. Discretionary Selection (Selection Method 3)
 4. Next Best World Cup Result (Selection Method 4)
- Selection Method 1 will be based on performances in Evaluative Events (Section 5) from September 6, 2024 through March 30, 2025.
 - Selection Methods 2 & 4 will be based on performances in Evaluative Events as defined in Section 5.
 - Selection Method 3 will be based on performances from September 6, 2024 to January, 18 2026.

6.2.1 Selection Method 1 - Objective Criteria – Top USA Athlete, in the top 3, on the 2024/25 FIS/WSPL Ranking Lists:

6.2.1a - Halfpipe

Up to one (1) athlete per gender will be nominated to the Games based on the following criteria: the top one (1) U.S. athlete, respective of gender, ranked in the top three (3) on the World Snowboard Points List (WSPL) Halfpipe as of 4/1/2025, shall be nominated.* Preliminary Notification linked [HERE](#)

6.2.1b Slopestyle/ Big Air

Up to one (1) athlete per gender will be nominated to the Games based on the following criteria: the top one (1) U.S. athlete, respective of gender, ranked in the top three (3) on the WSPL for Slopestyle as of 5/1/2025, shall be nominated.* Preliminary Notification linked [HERE](#)

*Ties for 6.2.1a and 6.2.1b will be broken by comparing each athlete's best WSPL point performance during the 24/25 season. This process may repeat as many times as needed to break the tie using each athlete's next best WSPL point performance during the 24/25 season. 6.2.1c - Snowboard Cross - Individual Event

Up to one (1) athlete per gender will be nominated to the Games based on the following criteria: the top one (1) U.S. athlete, respective of gender, ranked in the top three (3) on the 2026 FIS Snowboard Cross Base List, shall be nominated.** When published, the 2026 FIS Base List can be found [HERE](#). Preliminary Notification linked [HERE](#).

6.2.1d - Parallel Giant Slalom

Up to one (1) athlete per gender will be nominated to the Games based on the following criteria: the top one (1) U.S. athlete, respective of gender, ranked in the top three (3) on the 2026 FIS Parallel Base List, shall be nominated.** When published, the 2026 FIS Base List can be found [HERE](#). Preliminary Notification linked [HERE](#).

**Ties for 6.2.1c and 6.2.1d will be broken by taking each athlete's next best World Cup result during the 24/25 season. This process may repeat as many times as needed to break the tie. World Cup results can be found here: <https://www.fis-ski.com/DB/general/calendar-results.html>

After the Selection Method 1 has been applied, any unfilled quota slots will be filled in sequential order by Selection Methods 2 through 4.

6.2.2 Selection Method No. 2 – Top 10 World Cup Result:

6.2.2a - Halfpipe

Up to two (2) athletes, per gender, will be nominated for the Games based on an athlete's best single top ten (10) individual result from the Evaluative Events listed in Section 5 according to the WSPL points allocated for the event. **A third athlete per gender may qualify by Selection Method 2 (6.2.2a) if no athlete from the respective gender meets the above objective criteria for Selection Method 1 (6.2.1a).*

6.2.2b Slopestyle/ Big Air

Up to two (2) athletes, per gender, will be nominated for the Games based on an athlete's best single top ten (10) individual result from the Evaluative Events listed in Section 5 according to the WSPL points allocated for the event. **A third athlete per gender may qualify by Selection Method 2 (6.2.2b) if no athlete from the respective gender meets the above objective criteria for Selection Method 1 (6.2.1b).*

6.2.2c - Snowboard Cross - Individual Event

Up to two (2) athletes, per gender, will be nominated for the Games based on an athlete's best single top ten (10) individual result from the Evaluative Events listed in Section 5. **A third athlete per gender may qualify by Selection Method 2 (6.2.2c) if no athlete from the respective gender meets the above objective criteria for Selection Method 1 (6.2.1c).*

6.2.2d - Parallel Giant Slalom / Parallel Slalom

Up to two (2) athletes, per gender, will be nominated for the event based on an athlete's best single top ten (10) result from the Evaluative Events listed in Section 5. **A third athlete per gender may qualify by Selection Method 2 (6.2.2d) if no athlete from the respective gender meets the above objective criteria for Selection Method 1 (6.2.1d).*

*Ties for 6.2.2a-d will be broken by:

- Taking each athlete's next best World Cup result from the Evaluative Events listed in Section 5. This process may repeat as many times as needed to break the tie.
- If a tie still remains, it will be broken by taking each athlete's best World Cup result during the 24/25 season. This process may repeat as many times as needed to break the tie. World Cup results can be found here: <https://www.fis-ski.com/DB/general/calendar-results.html>

After Selection Method 2 has been applied, any unfilled quota slots will be filled in sequential order by Selection Methods 3 & 4.

6.2.3 Selection Method 3 (if applicable) – Discretionary Selection:

Up to twenty-five percent (25%) of total quota slots (male and female athletes combined) may be filled based on athlete petitions for discretionary consideration (see Section 7 below). Athletes must submit a petition to the U.S. Ski & Snowboard Selection Committee during the Selection Period (start of the 2024/25 through January 18, 2026) for nomination to the 2026 Olympic Team through discretionary selection. All petitions must be submitted through the online form which will be made available at <https://www.usskiandsnowboard.org/>

After Selection Method 3 has been applied, any unfilled quota slots will be filled by Selection Method 4.

6.2.4 Selection Method 4 (if applicable) – Next Best World Cup Result:

If there are quota slot(s) remaining after applying Selection Methods 1, 2, and 3, athletes with the next highest World Cup result from the Evaluative Events in Section 5 will be nominated to the 2026 Olympic Team.

In the event two athletes from the same or different disciplines tie, it will be broken by:

- Taking each athlete's next best World Cup result from the Evaluative Events listed in Section 5. This process may repeat as many times as needed to break the tie.
- If a tie still remains, it will be broken by taking each athlete's best World Cup result during the 24/25 season. This process may repeat as many times as needed to break the tie. World Cup results can be found here: <https://www.fis-ski.com/DB/general/calendar-results.html>

In the event of a conflict between this overview and the FIS Qualification System, the FIS Qualification System will take precedent.

SECTION 7: DISCRETIONARY CRITERIA TO NOMINATE ATHLETES

7.1 RATIONALE FOR UTILIZING DISCRETIONARY SELECTION:

Up to twenty-five percent (25%) of total quota slots (male and female athletes combined) may be filled using Selection Method No. 3 for nomination of athletes to the Team via discretion if they have indicated the potential for Olympic success.

There are two scenarios for which U.S. Ski & Snowboard may use discretionary selection criteria:

- **Athlete Nomination:** Nominating athlete(s) to fill available quotas that are not filled through

Selection Methods 1 & 2 (see Section 6). These athletes must have demonstrated previous Medal Capable results.

- **Team Composition:** Fielding the best snowboard athlete(s) with medal capability, future medal capability, and/or nominating athletes who can achieve the best results at the Games.

7.2 DEFINE THE DISCRETIONARY CRITERIA TO BE USED:

The Selection Committee will review data on all athletes when evaluating petitions for consideration for discretionary selection and will consider the following criteria in no particular order when making nominations:

- **Medal Capable Athlete:** A medal capable athlete is one who had a World Cup podium finish in the 2024-25 season or a Top 10 individual World Cup finish in the 2025-26 season prior to January 19, 2026.
- **Athlete Success in Individual Events:** The athlete's ability to maximize Team USA's success in individual events with open start positions based on Top 10 performances in Evaluative Events (Section 5) during the 2024-25 and 2025-26 season.

7.3 SELECTION COMMITTEE

The committee that will be responsible for making discretionary selections or other decisions and recommendations directly impacting athletes in the selection process.

- Snowboard Athlete Representative (non-competing) selected by the Athletes' Council

SECTION 8: MANDATORY TRAINING AND/OR COMPETITION

Specify the location, schedule, and duration of all mandatory training and/or competition that will be considered in Team selection.

Athletes may be required to attend a mandatory training camp(s) and/or competition(s) to be held at a venue to be announced. Any mandatory training camp(s) and/or competitions after the date of nomination will be announced at least thirty (30) days prior to the start of training or competition. Location, schedule, and duration of any mandatory training and/or competition will be posted on U.S. Ski & Snowboard website

Waivers from a mandatory training camp(s) and/or competition(s) will not be unreasonably withheld. Requests for a waiver must be submitted in writing to the U.S. Ski & Snowboard Snowboard Sport Director as far in advance as possible.

SECTION 9: DATE OF TEAM NOMINATION

U.S. Ski & Snowboard will nominate the Team, including any replacements/alternates to the USOPC on or before **January 20, 2026**.

If U.S. Ski & Snowboard does receive any additional quota through FIS reallocation, those athletes will be nominated to the USOPC on **January 23, 2026**.

SECTION 10: REMOVAL OF ATHLETES FROM THE TEAM

10.1 NGB JURISDICTION

U.S. Ski & Snowboard has jurisdiction over athlete nominees until athlete entries have been submitted by the USOPC to the Organizing Committee of the Olympic Games (OCOG).

- a. An athlete who is nominated to the Team by U.S. Ski & Snowboard may be removed for any of the following reasons, as determined by U.S. Ski & Snowboard:
 - i. Voluntary withdrawal. Athlete submits a written letter to the U.S. Ski & Snowboard President & CEO or Chief of Sport requesting to voluntarily withdraw from the Team.
 - ii. Injury or illness. A physician (or medical staff) approved by U.S. Ski & Snowboard provides certification that the Athlete has a debilitating condition. If Athlete refuses to provide verification of their illness or injury by a physician (or medical staff), their injury will be assumed to be debilitating, and they may be removed from the Team.
 - iii. Failure to participate. Athlete does not participate in all Mandatory Training and/or Competition as defined in these procedures.
 - iv. Code of Conduct Violation. Athlete violates the U.S. Ski & Snowboard Code of Conduct: <https://uskiandsnowboard.org/safesport-athlete-safety>
 - v. Athlete Agreement. Athlete violates a term in their signed U.S. Ski & Snowboard Athlete Agreement.
 - vi. Non-compliance. Athlete does not meet the athlete eligibility requirements listed in Section 3 and Section 4 of these selection procedures.
- b. An Athlete may be removed as a nominee to the Team or from the Team if found to have violated IOC, WADA, FIS, USADA and/or USOPC anti-doping protocol, policies and procedures, the U.S. Center for SafeSport Code, the USOPC Athlete Safety Policy and NGB SafeSport policies, as

applicable.

10.2 USOPC JURISDICTION

- a. Once Athlete entries have been submitted by the USOPC to the Organizing Committee of the Olympic Games, the USOPC has jurisdiction over the Team.
- b. USOPC's Delegation Conduct Requirements apply in addition to the NGB Code of Conduct. The Delegation Conduct Requirements in the USOPC Games Delegation Terms are specific to each Games and are made available during the Games registration process.
- c. The USOPC's Grievance Procedures and Hearing Process are found within the USOPC Dispute Resolution Policy and Hearing Procedures.

SECTION 11: SELECTION PROCESS IF ATHLETE VACANCY OCCURS PRIOR TO SUBMISSION OF ENTRIES BY NAME TO THE ORGANIZING COMMITTEE OF THE OLYMPIC GAMES

11.1 Should a vacancy occur prior to submission of Entries by Name by the USOPC to the Organizing Committee of the Olympic Games, the athlete may be replaced by the U.S. Ski & Snowboard Selection Committee using Selection Methods 2 through 4, in order, to fill the specific gender and discipline quota to be replaced. Any replacement of athletes must comply with these selection procedures, IOC, USOPC, and FIS regulations and entry deadlines.

11.2 All replacement athletes must meet all requirements listed in Sections 3-4.

SECTION 12: SELECTION PROCESS IF ATHLETE VACANCY OCCURS AFTER SUBMISSION OF ENTRIES BY NAME TO THE ORGANIZING COMMITTEE OF THE OLYMPIC GAMES

12.1 Should a vacancy occur after submission of Entries by Name by the USOPC to the Organizing Committee of the Olympic Games, if allowed, the same process will be followed as specified in Section 11.

12.2 All replacement athletes must meet all requirements listed in Sections 3-4.

SECTION 13: RIGHT TO A HEARING

An athlete who is removed from the Team has the right to a hearing per the [U.S. Ski and Snowboard's](#)

SECTION 14: REQUIRED DOCUMENTS

In addition to the USOPC Delegation Conduct Requirements, the following documents are required to be signed by an athlete as a condition of nomination to the Olympic Games.

SECTION 15: DISCLAIMERS

These procedures are based on IOC and FIS rules and regulations as presently known and understood. Any change in the selection procedures caused by a change in IOC and/or FIS rules and regulations will be distributed to the affected athletes immediately. The selection criteria are based on the latest information available to NGB.

However, the selection criteria are always subject to unforeseen, intervening circumstances, and realistically may not have accounted for every possible contingency. If any force of nature, pandemic, or force majeure, should cause the alteration or cancellation of any of the selection events listed in this document, these selection procedures may require revisions, pursuant to their resubmission to the USOPC.

SECTION 16: CONFLICT OF INTEREST

All members of the Selection Committee (Section 7.3) and all individuals who developed these selection procedures (Section 21) must comply with the U.S. Ski & Snowboard Conflict of Interest Policy, to include completing and submitting a disclosure form consistent with the U.S. Ski & Snowboard [Conflict of Interest Policy](#) before convening the committee.

Any person with a good faith belief that a committee member has a conflict of interest may report the alleged conflict of interest to the NGB [Ethics Committee](#). Reports may also be made anonymously through the [USOPC's Integrity Portal](#). No committee member shall retaliate in any way against a person who, in good faith, reports an alleged conflict of interest. In addition, the USOPC maintains a strict no retaliation policy that prohibits any employee, contractor, agent, volunteer, or member of the USOPC to take or threaten to take any action against an athlete for reporting information to or seeking assistance from the Office of the Athlete Ombuds.

Any recused individual shall be replaced in accordance with the NGB Selection Committee appointment process.

SECTION 19: NON-RETALIATION

The USOPC and NGB have zero tolerance for retaliation against people who make good faith reports of potential ethical, policy, or legal violations, or who cooperate with investigations of those reports. That means no USOPC or NGB staff, Board or Committee member, or volunteer may threaten, harass, discriminate against, or take any negative employment or related action (e.g., discharge, demotion, suspension, negative review) on that basis.

APPENDIX B – GLOSSARY

Contingency means a future event or circumstance which is possible but cannot be predicted with certainty.

Delegation Event means the Olympic Winter Games and the Paralympic Games representing the NGB in a sport recognized by FIS.

Force Majeure means an event or effect that cannot be reasonably anticipated or controlled (e.g., hurricane, tornado, etc.).

Grievance Procedures means the process that enables an athlete to file a complaint with the NGB or USOPC.

Jurisdiction means the power or authority to make decisions and judgments.

Nominated means an athlete, coach, or staff member whose name has been submitted to the USOPC by an NGB for participation in a Delegation Event.

Protected Competition means a Delegation Event or a Qualifying Competition.

Qualifying Competition means any World Cup or Grand Prix event in a discipline recognized by FIS for which a competitive selection process was administered by the NGB.

Selected means an athlete, coach or staff member whose name has been submitted by the USOPC to the OCOG at the final submission date, as determined by the OCOG.
